

## **URGENT APPEAL - THE OBSERVATORY**

GMB 001 / 0211 / OBS 015 Intimidation / Fear for physical integrity The Gambia February 9, 2011

The Observatory for the Protection of Human Rights Defenders, a joint programme of the International Federation for Human Rights (FIDH) and the World Organisation Against Torture (OMCT), requests your urgent intervention in the following situation in **The Gambia**.

## **Description of the situation:**

The Observatory has been informed by reliable sources about threats against *Daily News* journalist **Saikou Ceesay**.

According to the information received, on February 3, 2011 at 11 p.m., as Mr. Saikou Ceesay was approaching the door of his house he was stopped by Mr. Dinesh Shukla, President of the American International University for West Africa, and two other men. Mr. Shukla acted in a threatening and aggressive manner. Mr. Saikou Ceesay successfully escaped and entered his house. He has been on hiding since then.

On February 8, 2011, Mr. Saikou Ceesay filed a complaint at the Brusubi police station. The police opened an investigation.

On January 3, 2011, Mr. Saikou Ceesay had published an article on the *Daily News* to denounce the opening of a scam private university in the Gambia which aimed at swindling money from prospective students.

The Observatory is concerned about the safety of Saikou Ceesay and requests the authorities to promptly investigate into these facts and meanwhile ensure the protection of Mr. Saikou Ceesay.

## **Actions requested:**

The Observatory urges the authorities of The Gambia to:

- i. Guarantee in all circumstances the physical and psychological integrity of Mr. Saikou Ceesay, as well as all human rights defenders in The Gambia;
- ii. Ensure in all circumstances that Mr. Saikou Ceesay be able to carry out his work without hindrances;
- iii. Comply with all the provisions of the United Nations Declaration on Human Rights Defenders, in particular with
- Article 1, which provides that "everyone has the right, individually and in association with others, to promote and to strive for the protection and realization of human rights and fundamental freedoms at the national and international levels",
- Article 6 which provides that "everyone has the right, individually and in association with others (a) To know, seek, obtain, receive and hold information about all human rights and fundamental freedoms, including having access to information as to how those rights and freedoms are given effect in domestic legislative, judicial or administrative systems; (b) As provided for in human rights and other applicable international instruments, freely to publish, impart or disseminate to others views, information and knowledge on all







human rights and fundamental freedoms; (c) To study, discuss, form and hold opinions on the observance, both in law and in practice, of all human rights and fundamental freedoms and, through these and other appropriate means, to draw public attention to those matters",

- as well as with Article 12.2 which provides that "the State shall take all necessary measures to ensure the protection by the competent authorities of everyone, individually and in association with others, against any violence, threats, retaliation, *de facto* or *de jure* adverse discrimination, pressure or any other arbitrary action as a consequence of his or her legitimate exercise of the rights referred to in the present Declaration").

iv. More generally, ensure in all circumstances the respect for human rights and fundamental freedoms in accordance with in accordance with the Universal Declaration of Human Rights and with international and regional human rights instruments ratified by the Gambia.
