Angelita Baeyens, lawyer

Program Director - *Partners for Human Rights* of the Robert F. Kennedy Center for Justice and Human Rights (RFK Center) in Washington, DC, USA. At the RFK Center she works with organizations and human rights defenders from different regions of the world on the promotion and protection of human rights through advocacy, strategic litigation, and training. Mrs. Baeyens worked as a political officer in the Department of Political Affairs of the United Nations and previously as Human Rights Specialist in the Inter-American Commission on Human Rights (IACHR). At the Commission, she served as Coordinator of the Special Rapporteur on Human Rights Defenders from late 2009 until March 2012. In that capacity, Mrs. Baeyens directed and participated in the writing and editing of the Second Report on the Situation of human rights defenders in the Americas by which the Commission identified additional protection standards established in its first report on this subject, discussed emerging challenges in the exercise of the right to defend human rights defenders, and other situations in which human rights defenders are especially vulnerable. Angelita is also an adjunct professor at the Faculty of Law at Georgetown University.
